

SWIMMING POOL CONSTRUCTION CERTIFICATION AND PLAN SUBMITTAL

As per Idaho's RULES GOVERNING CONSTRUCTION AND OPERATION OF PUBLIC SWIMMING POOLS, No person shall construct or remodel any public pool until plans, specifications, and a plan review fee have been submitted, and the Director's designee has issued a letter of acceptance. Plans and specifications shall be prepared by an architect or engineer licensed to practice in the State of Idaho. The architect or engineer's plans, specifications and reports, shall contain information sufficient to demonstrate the proposed pool is in compliance with these rules and shall so certify.
