On the first screen you are presented with the ability to enter information in one or a combination of fields for a search:

When you have entered or chosen the information you want to search, click the Start Search button

Click Help button to see more instructions how to enter search parameters

By default, the Search routine looks for all SUBDIVISIONS and produces a listing of the selected records that match the criteria. In order to narrow your selection, option boxes are provided. By selecting one or more of these options, the Search looks for content only within the selected content set.

The next screen will show the results of your search. Use the scroll bar to move to the right to see more information about the Subdivision file. If there are multiple pages, you can use the arrows to navigate up or down the list. If you don't see the file you want, click the New Search button to go back to the Search screen to enter different information.
